#### COMMUNITY DIALOGUES IN CHITUNGWIZA

Councillors are democratically elected by the residents and ratepayers of the municipality. Once elected, they are responsible for reviewing matters and debating issues before their council. NAYO managed to conduct community dialogues in Zengeza East, Zengeza West, and Seke where Councellors held update meetings with residents. Concerned youths and women attended the meetings in their large numbers with full gender representation of both males and females considered.

The initiative is being carried out at a time where the country is facing the new COVID-19 Omicron wave. Social interactions have not been banned and this has allowed the full interaction of residents to discuss openly under a physical set up. The youth remain adamant and vigilant in attending and engaging in dialogues with the respected local authorities as action and full collaboration is needed in order to pave way for development in the community.

The community of Chitungwiza faces several challenges including: poor roads, abuse of young women and girls at water points and shortage of water in all 25 wards. Residents have taken up

these issues to be serious concern in need of urgent attention from both local and national level. Residents have of late blamed poor service delivery on the council with emphasis being put on corruption as being the lead cause of failure to deliver services to residents. "Council officers have turned to corruption for survival, demanding bribes to collect refuse and repair leaking or broken sewer lines." States Zengeza West resident. Another concerned resident submitted that. "It is worrisome that we continue to pay rates while service delivery is declining. Zengeza West Council is failing to meet it's mandate on service delivery."

Refuse collection has been affected due to lack of adequate refuse collection vehicles. Council has purchased two refuse trucks which have not started working due to insufficient fuel funds. Residents are also demanding their own source of water and other service delivery needs.

Ward 23 councillor Dingu responded to claims that council doesn't address service delivery issues in Chitungwiza clearly articulating how the council operates. He called for people to continue contributing to council operations and acknowledged the challenges being faced.









#### LEAVE NO YOUTH BEHIND CAMPAIGN

The LeaveNoYouthBehind2O23 Campaign, a non-partisan campaign which brings together all political divides and which is driven by the Youth and inspired by the quest for universal suffrage. The campaign seeks to improve the participation of Youth in the election cycle leading to the 2O23 Harmonized Elections by complementing the efforts of the Zimbabwe Election Commission (ZEC) through five pillars: supporting efforts at civic education (Go Educate); to mobilize citizens for registration (Go Mobilize; Go Register) highlighting the importance of universal suffrage (Go Vote) and fostering civic engagement between Youth and elected leaders (Go Demand).

During the 1st phase of the biometric voter registration blitz, the campaign has managed to Register hundreds of youths across the country through the multiplier effect as the coordinators continue to spread the word of registering to vote to young people.

The initiative has largely contributed to improve the capacity and capabilities of youth to engage in political and electoral processes. In February, the campaign had a Twitter space dialogue and a radio interview which were encouraging young people to

be part of the electoral and political process.

### VOTER MOBILISATION SCENES IN CHITUNGWIZA: YOUNG PEOPLE ARE READY TO MAKE THEIR VOICE HEARD

Youth in Chitungwiza said they are more enthusiastic than usual about voting; as the incredible number was energized and motivated to register to vote.

A lot of youths were not aware of how to register to vote while others did not have national identity documents threatening them from exercising their democratic right ahead of the country's upcoming by-elections and national elections scheduled for next year.

Meanwhile the second phase of mobile voter registration blitz is expected to run from 11 April to 30 April this year. The Zimbabwe Electoral Commission (ZEC) has set up mobile registration centres in areas where there are no permanent ZEC offices, and the mobile voter registration blitz will be conducted at 2 700 mobile registration centres.

Although time is running out to both register to vote and to educate young people on the importance of youth participation in national processes, it's definitely not too late to do either. Young people are the backbone of a society and their participation in all aspects of society is important. We encourage more and more youth to register to vote and turn out in numbers in March 26's national by-elections.



Youth become empowered by their participation in the institutions and decisions that affect their lives which in turn can lead to real positive change in the community. Their opinions shouldn't be dismissed out of hand on the grounds of age.
